# Signing Services Project Dependency Licenses

The signing service provides 3 separately deployable web applications:

- A signing service (CsSigServer)
- A test service provider (CSspServer)
- A sign support web service (CsSpSupport)

#### 2 Java Libraries

The signature services project depends on a number of open source java libraries that are included in the project as Maven dependencies.

#### 2.2 Commercial licenses

The licensing terms for IAIK JCE places requirements on the project code to be released as open source under terms that are compatible with the licensing terms of IAIK.

Some use of this project may require a commercial license for the IAIK library.

The IAIK library is used mainly to provide certificate creation and parsing functions. It was mainly used to save development time as it allowed reuse of some existing code.

All functions in this project that uses the IAIK library could be altered to use the Bouncy castle library instead.
